Volunteer to learn and share pro-life scientific, societal, legal, and safety knowledge to inspire yourself and many others to experience the goodness of life. Volunteers help kids win prizes in children's games. They can introduce how human life begins via human reproduction models, 11to14 week fetal babies, posters, videos, magazines, Options Pregnancy Center info, Pregnancy Aid brochures, and more. The fairground demolished the old Andy's Diner building eliminating our fundraiser this year. Human Life of Washington (HLW) has the "no sales fundraiser" policy in force for all its chapters. So, it could be several years before we have a new, meaningful Pro-Life fundraising event to augment donations. HLTC activities and events happen only when our volunteers, consumers, and donors keep the pro-life message alive.

Other news:

The abortion industry makes big money if they can get pregnant women to fear their unborn baby as a terrible problem that only death can fix. All are accountable for improving their life perspective. Joy-filled people help reduce others' distress, and envision wonderful possibilities as mom, baby, and future family. Let's grow!

Governor Inslee on 5/11/2023 cancelled his state employment Covid-19 vaccination requirement! The House Legislature kept [HB 1029](http://HB_1029) from the voters. The state need not re-employ the state workers he fired for having different beliefs about the injection. Executive branch agency workers must still re-apply for their old jobs.

Washington State legislators voted down Governor Inslee's proposed [amendment](#) to the [state constitution](#) to establish a fundamental human right deceptively titled "REPRODUCTIVE FREEDOM". Eighteen year-olds and up already have [marriage](#) and also reproductive freedom from government interference in two ways: First, via with Article 1 Section 7 on private affairs. Second in RCW statutory [abortion](#) law's [right to abortion](#). Their

freedom to get pregnant is not even limited by his “free” contraceptives. The [amendment](#) grants “*individuals*”, namely *women*, freedom to kill an innocent male or female human whom she naturally and sexually reproduces within herself. This abortion “*fundamental right*” reads like a form of women’s legalized [homicide](#).

Welcoming new unborn citizens and providing them future opportunities for a good family, school, friends, community, spousal relationship, and a decent job grows the state. But [abortion statistics](#) indicate that the state influences women to choose to kill tens of thousands of future American voters and tax payers every year. The state laws and policies favor abortionists’ knives and abortion drugs since death is cheaper than birthing.

The abortion constitutional amendment could [reappear next year](#). **Help people know that one human’s free choice should not be sanctioned by the state to cause another innocent human’s demise whether in the womb or after delivery.** Washington State does not stop with killing the unborn. They want to rid the sick and elderly too with laws for assisted suicide, mail order lethal drugs, and terminal diagnosis by non-physicians in [SB5179](#). Put your election votes to good use. Make the state exit the business of killing its innocent humans.

Of almost 17,000 unborn humans aborted in the state last year, abortion pills kill about [60%](#). For the USA it’s [54%](#) of all abortions. Attorney General (AG), Ferguson, wants to be governor in 2024. The AG says, [if it works](#), mifepristone (RU-486), the abortion pill designed to starve, suffocate, and shrivel the [fetus](#), is safer than Tylenol. It’s more dangerous than Tylenol to unborn humans! Some think [unborn humans](#) deserve better. Would the [mother feel ok](#) if it happens to her? She too deserves better than to be the one to kill her own.

After the abortion pill, if taken within 70 days of LMP, misoprostol pills soften the cervix. The uterus [painfully](#) ejects the up to 1.5 inch tall dead or [dying human](#), possibly into the woman’s toilet. This does not work for [ectopic pregnancies](#). Some regimens only use misoprostol pills. Both drugs can have significant physical and emotional [side effects](#). The woman as a home abortionist handles and disposes her former [symbiotic companion](#). Strangely, there is a law against [concealing its birth](#), dead or alive.

Jay Inslee, who signs bills into law, authorized spending [\\$1.27 million](#) for 30,000 abortion pills for medication abortions [plus 10,000 pills](#) more and then established the [Department of Corrections as a pharmacy](#) to sell them.

The AG’s [lawsuit](#) seeks to remove all the FDA mifepristone Risk Evaluation and Mitigation Strategy ([REMS](#)) information to make it easier to sell. The lawsuit claims removing the REMS is needed to provide “*vital access*” to mifepristone. Killing tens of thousands of unborn human beings cannot be a vital, absolutely necessary reason for requiring the FDA to remove the risk restrictions that have protected RU-486 users. The AG said without the RU-486 pills, increased surgical abortions and pregnancy care will increase the state’s healthcare costs. For profit or duty, every pro-abortion governor or AG, abortionist, and abortion drug company is in business to terminate a human life – a future artist, engineer, teacher, first responders, pastor, or spouse.

[Dobbs](#) exposed [legal flaws](#), considered [twenty years ago](#), in the repealed [Roe v. Wade](#) and [Casey](#) cases. Not grounded in constitutional law, it also relied on a [fetal development](#) viability fallacy. The pro-choice mantra, “[my body, my choice](#)” like “my house, my rules”. It doesn’t convey [authority to kill innocent humans](#) in one’s house or body. People know better today through science that a human [embryo](#) or fetus is an individual human life that is not its mother. It’s not her DNA, tissue, property, nor hers to destroy with any declared “right”.

An expectant mother can know with certainty that the unborn child is not a lump of her tissue. He or she is one of us human beings. She or he has its own separate living space within its mother. Insert a lump of foreign organic tissue into the woman’s body and it causes an infection, gets rejected and oozed out as puss. An unborn human life has its own unique DNA. It lives as a foreign organism for 9 months in its mother’s womb protected from her biological defenses. An unborn human living within a human, but remaining distinct from that human mother. He or she is not a sliver in her finger, but a precious gift for her and those around her as family.
